Sam and Ayala Zacks fonds

Dates of creation:

1923 - 1993, predominant 1947-1993

Extent:

7.6 m of textual records 1,292 photographs

Biographical Sketch:

Sam and Ayala Zacks were prominent Canadian art collectors of international repute active in the mid-20th century whose gifts form the basis of the modern European art collection at the Art Gallery of Ontario. Avala Ben Tovim Fleg Zacks Abramov (1912-) was born in Jerusalem and educated in Israel, Paris and London. In 1938 she married Maurice Fleg in Paris, and joined the French Resistance after her husband died in action in 1940. Active in Zionist circles after the war, she met Sam Zacks in Switzerland. Samuel J. Zacks (1904-1970) was a financier, Zionist and art collector, born in Kingston Ontario and educated at Queen's University and Harvard. Following their marriage in 1947 they immediately began to collect art of the School of Paris as well as Canadian and Israeli art and antiquities, amassing an extensive collection by the late 1950's that was in continual demand by museums around the world. In 1956 a collection of Canadian art was donated to Queen's University, Mr. Zacks' alma mater, the first of many significant gifts to institutions in Israel and Canada including the Hazor Archaeological Museum, the Royal Ontario Museum and the Art Gallery of Ontario. Mr. and Mrs. Zacks were both involved in international art circles, sitting on the Boards of the International Committee of Museums (ICOM), a branch of UNESCO, the International Committee of the Museum of Modern Art, the Art Gallery of Ontario and others. In 1969 Mr. Zacks received an Honourary Fellowship from St. Peter's College, Oxford. He died in 1970 in Toronto. After his death, Avala Zacks was awarded the Order of Canada and an honourary degree from the University of Toronto. She married Zalman Abramov, an Israeli lawyer and politician in 1976 and moved permanently to Israel in 1982.

Scope and content:

The fonds consists of correspondence with art dealers, artists and public art institutions, invoices, shipping and customs forms and other documents relating to their involvement in the international art market in the mid-20th century. Carbon copies of letters written by the Zacks and letters written to them are included. The fonds also contains the administrative files kept by the Zacks: insurance lists, index cards for art and books, photographs and catalogues. The fonds includes the records of the Zacks' involvement as board members in a variety of organizations relating to the arts, including agendas, memos, minutes of meetings, and travel arrangements. Correspondence files document the Zacks' involvement in the State of Israel, through its cultural institutions, and communication with prominent citizens. Mrs. Zacks' papers created after her husband's death relate to her honourary degree, the Order of Canada, board activities and social involvement.

Custodial history:

Material was received by the AGO in two stages, both originating from the office of Conreal, Inc., Mrs. Zacks' business office. There are notes indicating that the registrar's office received 28 boxes of records in 1990. Registration staff sorted the initial gift and photocopied items for their files; two students worked on the files in 1990 and 1991. By 1992 they were in the library's care. In June 1993 fourteen records boxes of papers were received by the library when Conreal was liquidated.

Notes:

Immediate source of acquisition:

Donatd by Conreal, Inc., in 1990 and 1993.

Arrangement:

It appears that the files were originally two separate filing systems, one kept by Mr. Zacks at his office on Bay Street, the other kept in the Zacks' homes and continued by Mrs. Zacks after her husband's death. The succession of secretaries with different filing habits further complicates arrangement; for example, an invoice for a work of art may be filed under the artist, the dealer or the year. An attempt at cross-indexing was made, with small typed sheets indicating the presence of related material in some files. The researcher is advised to check all possible access points. After the AGO acquired them the files were arranged into a single sequence, roughly alphabetical. The archivist has attempted to re-unite alphabetical and chronological series of correspondence based on the original file titles. Subjects have also been grouped based on original file titles. Two deviations from original order have been deliberate: it appears that exhibition catalogues and correspondence were filed together by artist and these have been separated to maintain their physical safety; a note indicates that sculptor files were originally separated from other artist files but all artists, regardless of media, now follow one alphabetical sequence. File titles are original, except where the title is encased in square brackets – [] – indicating that the title has been supplied. Order within files remains untouched.

Language:

Correspondence may be in French, Hebrew and occasionally German, as well as English.

Open. Access to Special Collections is by appointment only. Please contact the reference desk for more information.

Terms governing use and reproduction / publication:

Copyright is held by the creators and their heirs. It is the researcher's responsibility to obtain permission to publish any part of the fonds.
